David C. Najarian motioned, seconded by Kermit E. DeLong to appoint Andrew Foulk as an additional part time employee subject to all the terms at a rate of \$13.50/hr. Motion carried unanimously. Bruce Raber stated that Andrew Foulk does obtain a class B CDL and will be used for snow removal. The BOS also stated that Mr. Foulk may be used by Bruce Raber as he feels needed. The BOS approved Bruce Raber bringing in Mr. Foulk to familiarize him with the equipment and the roads. Bruce Raber also suggested that a list could possibly be formed to include more part time workers with CDL's that could be used in case of a snow emergency. The BOS stated that it may be considered at some time.

Misc.: (1) The Sewer Authority, at their February meeting, will be meeting with LCA to discuss finances. The SA has extended the invite to the BOS to be present at the meeting. Kevin Deppe stated that he will obtain an official invite from the SA to the BOS for the joint meeting and Kevin Deppe along with Donald Christ will draft the advertisement for the meeting and Lynn Township will pay for the advertisement. (2) A letter was received by the Dept. of Agriculture stating that The Sanctuary at Haafsville has not been approved as required under the Dog Law as a licensed kennel. Lynn Township, along with numerous other municipalities, is currently under contract with The Sanctuary at Haafsville, a no kill shelter, for the pick up of stray dogs and cats. Dave Najarian stated that prior to contracting with The Sanctuary at Haafsville, Lynn Township, as well as other municipalities, were contracted with The Humane Society. The Humane Society is a kill shelter, and in the past the township was unable to obtain the proper documentation to match the payment they were requesting. Dave Najarian suggested that Lynn Township draft a response letter to the Dept. of Agriculture acknowledgment receipt of the letter and also including in the letter that their letter has been forwarded to our solicitor for review. David Najarian stated that he will work with Kevin Deppe on drafting the letter.
