## Board of Supervisors Thursday, June 4th, 2009 @ 6:30 PM Lynn Twp.-7911 Kings Hgwy., New Tripoli

<u>Call to Order</u>: The re-scheduled meeting of the Lynn Township Board of Supervisors was called to order by Chairman Kermit E. DeLong Jr., at 6:30 pm in the Municipal Building. Present were Chairman Kermit E. DeLong Jr., Vice Chairman David C. Najarian, Member Thomas C. Creighton III, Zoning Officer/Township Manager Kevin N. Deppe, Secretary/Treasurer Tammy M. White, Solicitor Marc Fisher, NW Press reporter Ken Petrini, and approximately 31 citizens.

Pledge of Allegiance: The Pledge of Allegiance was conducted.

<u>Public Comment:</u> (1) - <u>Marvin Gruber of 7351 Fort Everett Rd., New Tripoli;</u> was present to discuss the Recreation Fee for new development on 2 acres that were subdivided in 1986. Mr. Gruber is asking for an exemption from possibly having to pay REC fees. Marc Fisher will review and let Kevin Deppe know on Monday, June 15, 2009.

Amusement Tax: An invitation for public comment was offered in consideration of Ordinance 94-02. No public comment was received. A motion was made by Thomas C. Creighton and seconded by Kermit E. DeLong to adopted Ordinance No. 09-02; AN ORDINANCE OF LYNN TOWNSHP, PA REPEALING ORDINANCE NO. 94-1 KNOWN AS THE "ADMISSION TAX ORDINANCE". David C. Najarian opposed. Motion carried.

Accept the Minutes and Direct the Treasurer to pay the bills: A motion was made by David C. Najarian and seconded by Thomas C. Creighton to accept the minutes from 05/14/09. Motion carried unanimously. A motion was made by Thomas C. Creighton and seconded by David C. Najarian to direct the treasurer to pay the water bill. Kermit E. DeLong recused himself. Motion carried. A motion was made by Thomas C. Creighton and seconded by Kermit E. DeLong to direct the treasurer to pay the remaining bills. David C. Najarian abstained from the vote. Dave Najarian prepared a Conflict of Interest Memorandum of Abstention in January 2008 because he recused himself in the event a bill would need to be paid to the Lynnport Fire Company. Motion carried.

<u>Subdivisions:</u> Marian E. Follweiler; waiver request: A motion was made by David C. Najarian and seconded by Thomas C. Creighton to grant a waiver, requested for Lot 2 of the subdivision, from the Lynn Township Subdivision and Land Development Ordinance for Section 425.4 which requires lot length to width ratio @ no greater than 3 to 1. Motion carried unanimously.

Park Report: Richard Matthias, Park Manager, reported for the month of April: (1) installed the rest of the railing at the band shell... but still needs to be painted. (2) Grass cutting & trimming. (3) Helped the road crew and took care of the transfer station due to Stanley Billig's absence. (4) Worked on new locks for the bathrooms at the pavilion because of vandalism. (5) Pulled weeds around the monument and tilled the flower beds between the brick walkway and the sidewalk around the monument. a) Tom Creighton brought up the issue of possible hiring Dennis Snyder part time to help out in Ontelaunee Park due to the absence of Stanley Billig and also possibly Richard Matthias who was hospitalized this week. Kevin Deppe stated that the part time summer help will be available on Friday, June 5, 2009. Dave Najarian stated that the issue of scheduling be left up to the Township Manager and Park Manager. Kevin Deppe will monitor the need for additional part time help for Ontelaunee Park. b) Kermit DeLong suggested that the area that was originally designated for the tennis & basketball courts, be seeded for more soccer fields which would benefit more people. Bruce Raber will look into the cost of topsoil. The BOS were in agreement to move ahead with the multi purpose field.

Road Report: Bruce Raber, Roadmaster, reported for the month of <u>April:</u> (1) Two road crew members helped cut grass in Ontelaunee Park. (2) Shoulder paving on eight township roads. (3) Made minor repairs on trucks. Anticipated work for <u>May:</u> (1) Finish shoulder paving. (2) Help Weisenberg & Heidelberg Townships with their paving projects. (3) Shoulder mowing. (4) Get roads ready for oil & chip.

<u>Budget:</u> Proposal for Lynn Township by Smith & Fager. Managing Partners, Dean Smith and Cheri Fager presented a proposal to identify and recommend opportunities for improvement to the township. Dave Najarian asked Smith & Fager to supply other planning references.

Car Cruise: Susan Giralico was present to discuss the plan for the car cruise which is scheduled for Saturday, July 11, 2009 from 5pm to 9pm in Ontelaunee Park. Susan Giralico noted that all proceeds will benefit Ontelaunee Park and that each vendor is required to submit 20% of their income. Dave Najarian suggested that it should be clarified whether or not the 20% requirement is on the gross or net sales of each vendor. Susan Giralico will confirm. Susan Giralico also added that the music will be provided by Jesse White at no cost. In addition to the cruise, Susan Giralico stated the need for a PA system in the future. A Parryville Band has graciously offered to perform for 1 hour on Tuesday, June 20, 2009 from 7pm to 8pm. Sue & Bob Bittenbender, from 7173 Borman Rd., New Tripoli, were present and asked the BOS if they would be able to be a vendor in the park. Kevin Deppe stated that he has not formulated an objective formal application or process. Dave Najarian added that any vendor will need to display their license and dispose of all their trash.

<u>Pioneer Days:</u> Richard Metzger confirmed that Crazy Elmer will be performing at Pioneer Days this year. Dave Najarian asked Richard Metzger if Crazy Elmer is in need of sponsors and if so they should contact him.

Humane Society: A motion was made by David C. Najarian and seconded by Thomas C. Creighton to table the issue until we find an alternate no kill shelter. Motion carried unanimously. Northwestern Press Reporter, Ken Petrini asked the BOS to let him know what we find out. Ken Petrini also added that other entities are also dealing with the issue entailed in the new 2009 agreement.

Weed Ordinance: Kevin Deppe stated that he was ok with the final draft of the weed ordinance. The weed ordinance will be sent back to the PC for their review.

Miscellaneous: Kevin Deppe reported: (1) Jason Rice from the NYAA is renting the park facilities on 06/11/09 and has requested to have the fees waived. Kevin Deppe stated that the Fire Companies are the only exempt entities and that all other organizations pay. A motion was made by Thomas C. Creighton and seconded by David C. Najarian to waive the fees for the NYAA this one time. Motion carried unanimously. (2) Lynn Township has been reimbursed from DEP \$82, 310.57. The amount is less than the amount listed in the application due to cost incurred before planning state date of 03/21/01. However there are 3 billing inquiries that DEP stated did not have sufficient documentation. The Township can either accept the check for \$82,310.57 and close the door or resubmit the documentation for the 3 billing inquiries, which were included in the original application. The additional reimbursement would be \$3,112.00. The BOS agreed to hold the check for \$82,310.57 and resubmit the 3 billing inquiries for reimbursement. (3) Richard Matthias spoke with Kevin Deppe regarding a request for a recorded easement on his driveway waiver. Marc Fisher stated that there was no waiver needed. (4) The townships lawn tractor has been repaired at Kermit Kistler as well as the JD 740 tractor located at the park. Kermit Kistler stated that 50% of repairs on the JD 740 will be covered under warranty and the township will be responsible for 50%. (5) Kevin Deppe addressed concerns by some, that the Township and its BOS have in the past and are currently mismanaging the Townships funds. In 2008 the 116K deficit was not due to excessive spending. The audits show a \$139,992 decrease from 2007 to 2008. This can be attributed partially to a .3 mil tax decrease that was considered by many to be the right thing to do at the time. This was a \$33,377.71 decrease in revenues. The Per Capita tax was also repealed with a net loss of \$12,828.30. Combining these two revenues which total \$46,216.01 played a part in the \$116K deficit. Also looking at the audits of 2007 & 2008, the townships liquid fuels monies in 2007 (monies received from the state) equaled \$205,551.23. In 2008 these funds dropped by \$6,977.70 to total funds received for liquid fuels to \$198,573.53. The zoning office showed a substantial decrease in revenues from \$161,255 in 2007 to \$93,341.00 in 2008, again, a loss of \$67,914.00 on the revenue side of the General Fund and a combined loss in revenues of nearly \$134,000. Expenditures in 2007 totaled \$1,494,610.00 and expenditures in 2008 totaled \$1,550,121.00 and increase of \$55,511.00. Nearly all of this increase in expenditures can be attributed to an increase in costs not directly associated with unnecessary spending but the costs to run the township. From 2007 to 2008 there was increase of \$5.37 per ton in asphalt; \$15.87 per ton of Salt; \$.37 per gal of oil for the roads. (6) Tom Creighton brought up the possibility of hiring Dennis Snyder PT to help Richard Matthias at the Park. Dennis Snyder is an elected auditor of Lynn Township and Marc Fisher will look into the legality issue of Dennis Snyder holding both positions. Note: reference a) under Park Report. (7) An email response was received from Joseph Buczynski, Environmental Engineer Manager of DEP in regards to the townships letter dated May 6, 2009. The email stated that confirmation will be needed as to the most cost effective process. Also issues concerning why the cost per user evaluation is only based upon \$2,600,000 and why haven't the best rates been considered. In addition there was concerns if the environmental clearances in the plan "PNDI, PA Fish Commission, PA Game Commission, US Fish and Wildlife and US DOI will cover any additional tankage that will be constructed beyond what was contemplated using the original 537 plan review and also if there is a site plan that shows the plant layout contemplated during the last 537 and how a best MLE process with additional tankage would compare and what are the limits of disturbance for this new process. David Najarian added that the townships support was with the proviso that DEP had no objection and that it is up to the SA to satisfy DEP. Roger Phillips with Gannett Flemming addressed Mr. Buczynski's concerns. Mr. Phillips sated that the costs provided in the study are preliminary estimates and once they are into preliminary design they will have a more accurate numbers to proceed with the selection of the vendor and specific package. Mr. Phillips also added in his response was that the best cost per user would be approximately 11% less, based on numbers in the study. In addition, Mr. Phillips stated that a topographic site survey and wetlands delineation was completed and is in the process of completion of a Phase II bog turtle study. This information is being compiled into a new site plan of the facility. Once the site plan is complete they will be performing the preliminary design to evaluate the size, location, configuration type of facility to be constructed taking into account all potential environmental impacts. The site plan and wetland delineation map will be forwarded when it is completed. (8) A motion was made by David Najarian and seconded by Thomas C. Creighton to send a donation equal to the cost of the services we used or reflecting the 2008 donation, to the Rural Preservation Association for Cleansweep 2009. Motion carried unanimously. (9) Dave Najarian announced that the Transfer Station will be closing at 1:00 pm on Saturday, June 6, 2009. (10) Kermit E. DeLong thanked Kevin Deppe for all of his help he does as Township Manager.

Public Comment: (1) Greg Snyder commented on the AARC/AQC concerning the overlay in a VC and RR district. Greg Snyder again review his points from a previous BOS meeting concerning the GCGI district and in regards to both the AQCOD and the proposed traffic study discussion ensued between supervisors and himself on this topic.

Announcements: None

Adjournment: A motion was made by David C. Najarian and seconded by Thomas C. Creighton to adjourn the meeting. Motion carried unanimously. Meeting adjourned at 7:50 pm.
