Board of Supervisors Thursday, July 11th, 2013 @ 6:30 PM Lynn Twp.~7911 Kings Hgwy., New Tripoli

<u>Call to Order</u>: The regular meeting of the Lynn Township Board of Supervisors was called to order by Chairman Justin N. Smith, at 6:30 pm in the Municipal Building. Present were Chairman Justin N. Smith, Vice Chairman Brian C. Dietrich, Member Kermit E. DeLong, Secretary/Treasurer Tammy M. White, Asst. Secretary/Treasurer Janet L. Henritzy, Road Master Bruce Raber, Engineer Roy Stewart, Solicitor Marc Fisher, and approximately 17 citizens.

Pledge of Allegiance: The Pledge of Allegiance was conducted.

Public Comment: (1) Resident, RoseMarie Faulk, addressed the BOS with concerns of a neighbor of hers located on Kings Highway that has at least 10 abandoned vehicles as well as the location not being taken care of. Ms. Faulk stated she did a written request in the fall of 2012 and nothing has been done. Engineer, Roy Stewart stated the location in question was sighted and that he is doing a follow up tomorrow, 7/12/13, and if nothing has been taken care of the issue will be sent to the magistrate. Solicitor, Marc Fisher stated that at the time the issue comes to him it could be anywhere between 20 and 40 days. (2) Sandra Kline, addressed the BOS with the possibility of being able to subdivide a lot off of her parents, Carl & Betty Miller's property. Engineer, Roy Stewart stated that he reviewed the issue with her and that she would be unable to do so because she doesn't have the required 30,000 square feet needed and that she can hire an engineer to review what she is proposing.

Accept the Minutes and Direct the Treasurer to pay the bills: A motion was made by Kermit E. DeLong and seconded by Brian C. Dietrich to accept the minutes from 06/13/13 and direct the treasurer to pay the bills. Motion carried unanimously.

<u>Subdivision-</u> (1) <u>Stan Kelson Final</u>: The LVPC submitted their letter of approval. A motion was made by Kermit E. DeLong and seconded by Brian C. Dietrich to grant final conditional approval based on KCE letter dated 5/21/13 and the approval from DEP. Motion carried unanimously.

Fire Companies- NTFC Fire Chief, Peter Christ reported for the month of June.

Road Report: Bruce Raber, Road master, reported for the month of June: (1) Filled pot holes on dirt roads. (2) Built up and widened the north side of Miller Rd. and did a penetration job to convert the road from dirt to asphalt. (3) Helped Weisenberg Twp. with their oiling & chipping. (4) Worked twice on dirt roads after heavy rains. (5) Finished up all of Lynn's oil & chipping. (6) Cut grass at recycling center. Anticipated work for July: (1) Help Heidelberg Twp. with their oil & chipping. (2) Help Lowhill with their oil & chipping. (3) Work on dirt roads. (4) Fill in some small wash outs. (5) Cut some shoulders on black top roads. Falcon Ct.: Bruce Raber stated he has not had a chance to speak with the residents regarding the driveway across from Falcon Ct. but he did report that there is a large roller in the driveway and that maybe they plan on paving. Bruce Raber added that he will make a point to talk to the residents. Penn Dot did state that they were going to cut the gutter. Solicitor, Marc Fisher stated that he contacted Pergosky's representative and has not received a response. Resident, Dave Najarian also added discussion on the acceptance of the road. Justin Smith stated he will look at it again because he had a different opinion on the acceptance. Engineer, Roy Stewart and Solicitor, Marc Fisher will be meeting on 7/19/13 to discuss the codification of ordinances and at that time they will review the acceptance of Falcon Ct. Behler & 143: A disclaimer letter was sent to DEP and Engineer Roy Stewart stated he would talk to someone in the Maintenance district at Penn Dot regarding the sink hole. Sending letters to the neighbors was discussed but possibly first speak with the neighbors before sending letters.

<u>LCA Update:</u> Frank Leist: Mr. Leist presented the BOS with a memo summarizing LCA efforts from 12/1/12 through 6/31/13 and added that the system is operating very well.

Resolution 2013-19: A motion was made by Brian C. Dietrich and seconded by Kermit E. DeLong to adopt Resolution 2013-19; A RESOLUTION OF THE BOARD OF SUPERVISORS OF LYNN TWP, LEHIGH COUNTY, PA FOR THE TRANSFER OF UNENCOMBERED MONEYS FROM ONE TOWNSHIP ACCOUNT TO ANOTHER. Motion carried

unanimously. The resolution was to transfer monies from the Rec account to the GFMM for reimbursements for Park purchases.

<u>Donations:</u> A motion was made by Kermit E. DeLong and seconded by Brian C. Dietrich to keep the 2013 donations the same as in 2012. Motion carried unanimously.

Miscellaneous: (1) Concession Stand: Janet Henritzy reported that construction is underway. (2) Band Shell: Janet Henritzy reported that she has a quote from Reppert Painting to do the band shell and has also spoke with the Rotary Club to see if they would have an interest staining the band shell. A motion was made by Briand Dietrich and seconded by Kermit E. DeLong to see if the Rotary Club would be interested in the project and if they are ok but if not interested in the project, contact Reppert's to do the project and not to exceed their quote of \$1,080.00. Motion carried unanimously.

(3) Spraying License: Tammy White reported that Robert Acker is in the process of reviewing the material. (4) Nestle: Brian Dietrich stated that Nestle dropped off their 2012 Annual Monitoring Report for Hoffman's Springs and that if anyone was interested in reviewing it, it was in the office.

<u>Public Comment</u>: (1) <u>Resident, Dave Najarian</u> addressed the BOS with his concerns regarding the transfer station operator and their duties in assisting residents and keeping the grounds clear of debris. Resident, Sue Giralico added that our transfer station has listed that they only accept a certain # plastics but yet Cougles who picks up our recyclables accepts up to #7 plastics. Tammy White will call Berger Sanitation to see what their prices are for the recyclables and compare to Cougles and will also inquire about magnetic signs for the bins as the issue was presented by Resident, Russell Wambold that the bins should be marked better. (2) <u>Resident, Faye Dietrich</u> stated to Justin N. Smith that she was waiting for an apology regarding an email that was sent out by Justin N. Smith. Justin N. Smith did clarify that he did send the email. Kermit E. DeLong stated that enough is enough and that this is not a township issue and that it is a personal issue.

Announcements: (1) Justin Smith announced that township employee Randy Schmoyer became a first time dad to a baby girl. (2) 5th Annual Car & Motorcycle Show; Sunday, July 14, 2013; 1pm till 4pm in Ontelaunee Park. \$5 entrance fee for all cars, trucks and bikes; free admission for spectators. (3) Night in the Country is scheduled for Saturday, August 17, 2013 with a rain date of Sunday, August 18, 2013.

Adjournment: A motion was made by Kermit E. DeLong and seconded by Justin N. Smith to adjourn the meeting. Motion carried unanimously. Meeting adjourned at 7:40 pm.
