<u>Call to Order</u>: The regular meeting of the Lynn Township Board of Supervisors was called to order by Chairman Justin N. Smith, at 6:30 pm in the Municipal Building. Present were Chairman Justin N. Smith, Vice Chairman Steve I. Feinour, Member Brian C. Dietrich, Secretary/Treasurer Tammy M. White, Admin/Zoning office Secretary Kathy A. Hermany, Road Master Bruce Raber, Engineer Chris Noll, Solicitor Marc Fisher, and approximately 5 citizens.

**Pledge of Allegiance:** The Pledge of Allegiance was conducted.

Media Representation: Kenny Bleiler, NWP.

Public Comment: None

Accept the Minutes and Direct the Treasurer to pay the bills: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to accept the minutes from 07/12/18 and direct the treasurer to pay the bills. Motion carried unanimously.

Fire Companies: LPFC 2nd Asst. Fire Chief, Tim VanBlargan reported for the LPFC: 33 call year to date; 4 member participated and received certification for water rescue and emergency response; Engine 1411 will be reporting to night in the country to provide lighting at the intersection of 309 and north west rd.; Utility 1492 will be utilized to assist medical personnel with patient transport within the park grounds. NTFC Fire Chief, Peter Christ reported for the NTFC: 132 fire calls to date; 7/30 water rescue training with station 14; food stand at Nite in the Country; steel is erected for new building and roof is being installed; guns and cash bash tickets are still available for the September event; pump, ladder and hose testing held off until spring of 2019.

Road Report: Bruce Raber, Road master, reported for the month of <u>July</u>: (1) Cut shoulders on Hummingbird rd. for paving. (2) Paved Basket Ball court in park and back entrance of park. (3) Swept roads that were oiled and chipped. (4) Paved Hummingbird rd. (5) 2 loads of scrap metal from recycling center = \$265.20. (6) replaced & repaired a few stop signs & road name signs. (7) 2nd round of shoulder mowing. (8) Replaced road pipe on Scholler Rd. 5' X 60'. (9) Scrapped old road pipe = \$353.05. (10) Made some repairs to a few dirt roads. Anticipated work for <u>August:</u> (1) Continue shoulder mowing. (2) Work on Dirt roads. (3) Fill in and plant grass at back entrance of park. Front Garage <u>paint</u>: A motion was made by Briand C. Dietrich and seconded by Justin N. Smith authorizing the front road crew garage building to be painted at the cost of \$1.990.00. Motion carried unanimously.

Resolution 2018-17: Destruction of specific records. A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to pass Resolution 20118-17; A RESOLUTION OF THE BOAD OF SUPERVISORS OF THE TOWNSHIP OF LYNN, LEHIGH, PA FOR THE DESTRUCTION OF SPECIFIC RECORDS. Motion carried unanimously.

<u>Park:</u> New Pavilion update: Footers are poured and its moving along. Slight delays because of all the rain. <u>Volley Ball Court</u>: Bruce Raber stated that he may get to the volley ball court area this year and if not he will do it in spring next year. <u>Line Painting</u>: The BOS were in favor of EDEGEONE going ahead and painting the Basket Ball court at park as well as the township parking lot.

Miscellaneous: (1) Veterans Memorial Account: The BOS directed Tammy M. White to open a savings account for deposit of all memorial funds that come in. (2) Girl Scout Unit 736: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to waive the park rental fees for their event on Sunday, October 7, 2018 because their event involves park clean up. Motion carried unanimously. (3) LCA: Steve I. Feinour along with Solicitor Marc Fisher met with LCA regarding the CAP for the sewer authority. Currently the system should allow for 24 additional EDU's. Further information is forth coming from DEP. (4) (5)
