## Board of Supervisors Thursday, August 8th, 2019 @ 6:30 PM Lynn Twp.~7911 Kings Hgwy., New Tripoli

<u>Call to Order</u>: The regular meeting of the Lynn Township Board of Supervisors was called to order by Chairman Justin N. Smith, at 6:30 pm in the Municipal Building. Present were Chairman Justin N. Smith, Vice Chairman Steve I. Feinour, Member Brian C. Dietrich, Secretary/Treasurer Tammy M. White, Admin/Zoning office Secretary Kathy A. Hermany, Road Master Bruce Raber, Engineer Chris Noll, Solicitor Marc Fisher, and approximately 5 citizens.

<u>Pledge of Allegiance</u>: The Pledge of Allegiance was conducted.

Media Representation: Kenny Bleiler, NWP.

Public Comment: None

Accept the Minutes and Direct the Treasurer to pay the bills: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to accept the minutes from 07/11/19 and direct the treasurer to pay the bills. Motion carried unanimously.

<u>Subdivision:</u> Paul Kuhn extension: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour approving the extension request thru October 31, 2019. Motion carried unanimously.

Fire Companies: LPFC 2nd Asst. Fire Chief, Tim VanBlargan reported for the LPFC: 34 emergency calls for the year; LPFC will be hosting a basic Fire Police class starting Sept 9th; Sept 7th from 2pm - 8pm will the LPFC 75th Anniversary parade; Sept 15th is the meat bingo. NTFC Fire Chief, Peter Christ reported for the NTFC: 82 fire calls as of 8/7/19; FF Phil Hobel passed his FFII pro-board certification; 2 FF completed truck 1&2; 1 FF completed Mod 3 of essentials; 1 FF passed basic vehicle rescue technician; will be at Night in the Country. Fire Fighters Retention & Recruitment Fund 2019: In 2018 the BOS stated the following: The BOS discussed that the money(10K) would be split between NTFC and LPFC based on amount of calls received from January thru September 30th. Calls will be reported at the October BOS meeting and the fire companies will have their money by November. The BOS agreed this is how it will be based each year going forward. The 2019 year will be the same.

Road Report: Bruce Raber, Road master, reported for the month of July: (1) Cleaned out gutters & cut shoulders. (2) Fixed up the wood fence on the train bridge in park. (3) Made repair to exhaust pipe on 6320JD shoulder mower. (4) Weed wacked around bridges & guide rails. (5) We had about 12 trees come down during storms. (6) Installed a 4' X 40' long road pipe. (7) Did some cold patching (about 3 tons). (8) Installed & replaced stop & road name signs. (9) Started cleaning out box culverts. (10) Hauled scrap metal - \$53.40 & aluminum cans - \$90.00 from recycling center and a scrap road pipe - \$93.00. (11) All double yellow lines have been painted. Anticipated work for August: (1) Work on cleaning box culverts. (2) Install another large pipe. (3) Work on some dirt roads. Ross Valley Bridge: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour authorizing KCE to put the Ross Valley Bridge repairs out for bid. Motion carried unanimously. KCE stated that the Ross Valley Bridge repairs would cost approximately 160K. Bruce Raber added that LFF money can be used toward the repairs. Park Bridge: The BOS were in favor of Bruce Raber obtaining 3 quotes to make repairs to the foot bridge in Ontelaunee Park. KCE estimates the repairs will be under the threshold of having to put out to bid.

<u>Proposed Sewer Amendments Update Ord. 2019-02:</u> A motion was made by Steve I. Feinour and seconded by Brian C. Dietrich authorizing Solicitor, Marc Fisher to advertise the ordinance. Motion carried unanimously.

Multi Municipal Comprehensive Plan Service Agreement: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour approving the Planning Services Agreement with the LVPC and the Municipalities of Heidelberg Township, Lowhill Township, Lynn Township, Slatington Borough, Washington Township, Weisenberg Township, collectively organized as a multi-municipal comprehensive planning area (Northern Lehigh and together with LVPC, the "Parties, and each a "Party". Motion carried unanimously.

Park: Dawn to Dusk Light: Chris Noll is working on the Dawn to Dusk light for at the dog park. Disk Golf: Kathy Hermany reported that the new disk golf sign have been delivered and will be put up in a few weeks. Arborvitae: The BOS stated that the 6 dead Arborvitae located in the park along the Murhy property should be replaced. Kathy Hermany will call Ross Post and have him come out an recommend a size. Dumpster: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour authorizing the purchase of a dumpster for Ontelaunee Park to be located at the maintenance garage. Motion carried unanimously. The dumpster will have a lock on it at all times. Maint. Garage: Justin N. Smith stated that an individual was caught stealing from the maintenance garage and another individual was seen inside the fence surrounding the garage. The State Police were called.

Miscellaneous: (1) Transfer Station: There are now 2 recycling bins located at the TS that need repairs. It will be looked into having them repaired. (2) Walking Trail: Brian Carl is going to meet with the road crews during set up of Night in the Country to review the walking trail project. Justin N. Smith stated that the project should be covered with grant money and Nestle money. (3) Chris Noll: Chris Noll stated that the Nestle Culvert Replacement does not affect the township. (4) Jan Sutermeister: Jan was present to give an update that the proposed pole committee passed their bylaws and once they obtain 5013C status they will move forward with feasibility study.
