<u>Call to Order:</u> The regular meeting of the Lynn Township Board of Supervisors was called to order by Chairman Justin N. Smith, at 6:30 pm in the Municipal Building. Present were Chairman Justin N. Smith, Vice Chairman Brian C. Dietrich, Member Steve I. Feinour, Secretary/Treasurer Tammy M. White, Admin/Zoning office Secretary Kathy A. Hermany, Road Master Bruce Raber, Engineer Rep./Zoning Officer Chris Noll, Solicitor Marc Fisher, and approximately 31 citizens.

<u>Pledge of Allegiance</u>: The Pledge of Allegiance was conducted.

Media Representation: Sarit Laschinsky from the NW Press.

Public Comment: None

Accept the Minutes and Direct the Treasurer to pay the bills: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to accept the minutes from 10/08/20 BOS meeting and to direct the treasurer to pay the bills. Motion carried unanimously.

Fire Companies: LPFC Asst. Fire Chief, Tim VanBlargan: 53 Emergency calls for the year; currently hosting a hazmat ops class at LP station with 9 members attending; Friday Nov. 0th is turkey raffle night which will be drawn @7pm via Facebook live; Nov. 24th is the filling and bacon dressing sale orders which are due by Friday the 13th pick up is 4-6pm on the 24th; Hoagie sale is December 2nd orders must be in by Nov. 27th. NTFC Fire Chief, Gary Kuntz: 139 Emergency call to date; 3 firefighters (Bill McQuilken, Derek Dorney, Cody Baugher) completed EVDC class held at Weisenberg Fire Company & Mack South; 4 firefighters (Bill McQuilken, Owen Snyder, Derek Dorney, Quintin Lawley) are currently taking Haz-Mat Operations at Lynn port Fire Company, Working on scheduling a Haz-Mat ops Pro Board testing session at New Tripoli, Working on annual Haz-Mat Ops refresher at New Tripoli; Trick or Treat night was Saturday 10/31, apparatus was set up with Fire Police at Decatur and Market Street; NTFC and Germansville Fire Depts, held a drive thru fire prevention event on Saturday, October 17 between 9am - 11 am in the parking lot of the strip mall at Route 309 & 100. Apparatus was on display and they gave free handouts to children with the Fire Prevention material; NTFC had representatives at the NW Regionalization meeting held on Wednesday 10/21 at NTFC; NTFC request a meeting with township officials last month and would to confirm a date to sit with supervisors and discuss the current challenges that will be coming in the near future; moving forward I would like to schedule an advertised meeting once every quarter at NTFC to encourage open transparent dialogue between the Fire Department and the Township. Steve Feinour stated that he would be in contact with Gary Kuntz to set up a meeting regarding day to day issues. No need to have all 3 Supervisors attend. The Fire Study was also discussed with possibly setting up meetings to continue with the Fire Study. Justin N. Smith stated the Fire Study was agreed upon by both Fire Companies and the BOS and stated that he feels the guidelines need to be completed. Brian C. Dietrich stated that he will not go along with the consolidation of NTFC and LPFC unless both Fire Companies agree. Back Home Bagel truck was a NTFC on Sunday, October 25th at 8am; Online raffles continue daily; Drive Thru Filling sale order deadline was 11/06, pickup 11/21 between 1-3pm, to date 700 containers have been sold; NTFC continues to meet with manufacturers to replace their 1997 Freightliner tanker, they continue to receive pricing and are working on finalizing a spec. The committee is meeting with the last manufacturer next Tuesday night 11/17.

Road Report: Bruce Raber, Road master, reported for the month of October: (1) Tree trimming - Leaser Rd. - Blue Mnt. House Rd. - Eile Dahl Rd. - Stump Rd. - Long Ct. - Old Orchard Ct. - Halpin Rd. - Koch Ct. - Sassafras Rd. - Lentz Rd. - Gun Club Rd. (2) Put up weight limit signs for Bridge on Ross Valley Rd. (3) Got trucks ready for winter. (4) Hauled scrap metal from Recycling Center \$138.00 and Aluminum Cans \$70. Anticipated work for November: (1) Finished up tree trimming. (2) Fill Pot Holes on Dirt Roads. (3) Start Boom Mowing. Memorial Road: A letter was received by PA Dept of Transportation regarding encroaching brush on state route 4028 (Memorial Rd.) 2 areas of concern are Oriole Road (Heidelberg Twp.) and Lochland (Lynn Twp.) Lochland has been taken care of and there is no line of site issue.

<u>Park:</u> Steve I. Feinour stated that New Employee Brandon Wehr is doing a fantastic job. The BOS were ok with Bruce purchasing Brandon a torpedo heater for the maintenance garage. There has been some vandalism at the park pertaining to benches being broken. The BOS directed Tammy M. White to call John Debrosky to install two cameras at the new pavilion. Also discussion was held regarding the existing plumbing that is the new pavilion. The caps that are sticking up through the floor are being broken. It was suggested to temporarily build something around the plumbed areas to prevent any serious damage.

Ordinance 2020-02: Marc Fisher opened a public hearing at 6:55 pm to review the ordinance. Resident Sherry Lienberger directed questions during the hearing. The hearing was closed at 7:09 pm. A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour adopting Ordinance 2020-02; AN ORDINANCE OF THE BOARD OF SUPERVISORS OF LYNN TOWNSHIP, LEHIGH COUNTY, PA AMENDING CHAPTER 27 OF THE CODE OF ORDINANCES, TOWNSHIP OF LYNN, TO ADD AND REVISE CERTAIN DEFINITIONS RELATING TO SHORT-TERM RENTALS OF RESIDENTIAL PROPERTY; REGULATING THE ZONING DISTRICTS WITHIN WHICH SHOR-TERM RENTALS OF RESIDENTIAL PROPERTY ARE PERMITTED; SETTING FORTH REQUIREMENTS FOR SHORT-TERM

RENTALS OF RESIDENTIAL PROPERTY AND THE CONDITIONS OF ISSUANCE OF PERMITS THEREFOR. Motion carried unanimously.

Feinour adopting Ordinance 2020-03; AN ORDINANCE OF THE BOARD OF SUPERVISORS OF LYNN TOWNSHIP, LEHIGH COUNTY, PA, AMENDING THE CODE OF ORDINANCES, TOWNSHIP OF LYNN, ESTABLISHING A WEIGHT LIMITATION FOR THE ROSS VALLEY ROAD BRIDGE IN LYNN TOWNSHIP, LEHIGH COUNTY, PA, AND ESTABLISHING PENALTIES FOR VIOLATION THEREOF. Motion carried unanimously.

**The Sanctuary-**: The BOS were not in favor of a set price of \$50 per cat and \$110 per dog. The BOS directed Tammy M. White to contact the Sanctuary to see if they would be in favor of re writing the contract to state "Not to Exceed a Certain Dollar Amount).

Tax Rate for Year 2021: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour approving Resolution 2020-13; A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF LYNN, LEHIGH COUNTY, FIXING THE TAX RATE FOR THE YEAR 2021. Motion carried unanimously. The Resolution was approved keeping the millage of Lynn Township 0.2 mills.

Budget Discussion: Motion to authorize advertisement of the 2021 budget for viewing; adoption 12/10/20; A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to authorize the advertisement of the draft 2021 budget for viewing. Motion carried unanimously.
