Call to Order: The regular meeting of the Lynn Township Board of Supervisors was called to order by Vice Chairman Steve I Feinour, at 6:30 pm in the Municipal Building. Accept the Minutes and Direct the Treasurer to pay the bills: A motion was made by Brian C. Dietrich and seconded by Steve I. Feinour to accept the minutes from 11/10/21 and to direct the treasurer to pay the bills. Motion

Fire Companies: NTFC Asst. Fire Chief, Nick Gruber: 193 Emergency calls to date, 3 Junior FF's & 1 Senior FF completed their MOD 2, 1 new member completed his Haz-Mat Awareness online, Bruce completed his Haz-Mat Technician certification, 7 members attended a forcible entry class at Whitehall training grounds, Christmas tickets are on sale for \$25 apiece. They start on 12/19 and are only selling 1K tickets. The prize on Christmas night is a 2022 Polaris 570 Sportsman Trail model with a snowplow, windshield and hand warmers. NTFC partnered with the NWLHS SADD chapter for a Toy Drive. Unwrapped toys can be dropped off at the station on Monday 12/13@ 6pm and Wednesday 12/18 @ 6pm. Annual Santa run will be on Saturday 12/15 and the station will be open from 11am - 1pm for photos with Santa. Apparatus will leave the station at 1pm and will be delivering gifts to children on route. Wrapped gifts with the child's name and address can be dropped off at the station the nights as the Toy Drive drop off. NTFC was featured in a promotional video by the New Tripoli Bank, FC provided lighting, traffic control and delivery of Santa Clause at the 1st Annual tree lighting at Ontelaunee Park, quarterly meter calibration was don in October, ensuring our meters are giving accurate readings when needed, annual air pack flow testing was completed, Cub Scout Pack 588 visit station on 2 separate nights for a tour, received a donation from Bob's Discount furniture in Whitehall for new recliners in fire team lounge. Motion carried. The resolution sets the Tax Certification at \$20, A Tax Duplicate at \$5 and the cancelled Check fee at \$50 and is effective January 1.

Feinour to readvertise to complete the changes to the codification and to authorize Marc Fisher and Chris Noll to work with staff; changes are Ord. 2006-10-Village Center made minimum lot area is to go back to 8,000 sq. ft. Page 27-23-Village Center, Blue Mountain, & Rural Residential under minimum yard requirements it says from center line of the road but in AP & R it does not say from centerline, this will be corrected and in the RV & GCGI there will be minimum yard requirements.
